On October 10, 2023, Shareholders of Heritage-Crystal Clean, Inc. (HCCI) will vote concerning the proposed merger with JFL-Tiger Merger Sub, a wholly owned subsidiary of JFL-Tiger Acquisition Co., Inc. If the merger is approved and consummated, each existing HCCI Common Share will be converted into the right to receive \$45.50 net cash per share.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur in the fourth quarter of 2023.

**New Deliverable**  
**Per Contract:** \$4,550.00 Cash (\$45.50 x 100)

Settlement in HCCI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
