Astra Space, Inc. (ASTR) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each ASTR Class A Common Share will be converted into the right to receive approximately 0.066667 (New) Astra Space, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on September 14, 2023. Fractional shares will be rounded up to the next whole share.
