**Subject:** Adjusted Heliogen, Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: HLG1

Adjusted Heliogen, Inc. options were adjusted on September 1, 2023 (See OCC Information Memo #53117). The new deliverable became 1) 2 Heliogen, Inc. (HLGN) Common Shares, and 2) Cash in lieu of approximately 0.8571 fractional HLG1 Shares. Only settlement of the cash portion of HLG1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.38 per whole HLG1 share will be used to determine the cash in lieu amount at a rate of 0.8571. Accordingly, the cash in lieu amount is:

$$0.8571 \times \$6.38 = \$5.47 \text{ per HLG1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 1, 2023 through September 18, 2023, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the HLG1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 2 Heliogen, Inc. (HLGN) Common Shares  
2) \$5.47 Cash

**Strike Prices:** Unchanged

**CUSIP:** HLG1: 42329E204

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The HLG1 component of HLG1 exercise/assignment activity from September 1, 2023 through September 15, 2023, has settled through National Security Clearing Corporation (NSCC). The \$5.47 cash amount will be settled by OCC.

**Pricing**

The underlying price for HLG1 will be determined as follows:

$$\text{HLGN1} = 0.02 (\text{HLGN}) + 0.0547$$

For example, if HLGN closes at 3.99, the HLG1 price would be calculated as follows:

$$\text{HLGN1} = 0.02 (3.99) + 0.0547 = 0.13$$
