Subject: Adjusted WeWork, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: WE1

Adjusted WeWork, Inc. options were adjusted on September 5, 2023 (See OCC Information Memo #53126). The new deliverable became 1) 2 WeWork, Inc. (WE) Class A Common Shares, and 2) Cash in lieu of 0.5 fractional WE Shares. Only settlement of the cash portion of WE1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.617243 per whole WE share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$4.617243 = \$2.31 \text{ per WE1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 5, 2023 through September 22, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the WE1 options are as follows:

New Deliverable

Per Contract: 1) 2 WeWork, Inc. (WE) Class A Common Shares
2) \$2.31 Cash

Strike Prices: Unchanged

CUSIP: WE: 96209A401

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The WE component of WE1 exercise/assignment activity from September 5, 2023 through September 21, 2023, has settled through National Security Clearing Corporation (NSCC). The \$2.31 cash amount will be settled by OCC.

Pricing

The underlying price for WE1 will be determined as follows:

$$\text{WE1} = 0.02 (\text{WE}) + 0.0231$$

For example, if WE closes at 3.57, the WE1 price would be calculated as follows:

$$\text{WE1} = 0.02 (3.57) + 0.0231 = 0.09$$
