Vaccinex, Inc. (VCNX) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each VCNX Common Share will be converted into the right to receive approximately 0.066667 (New) Vaccinex, Inc. Common Shares. The reverse stock split will become effective before the market open on September 26, 2023. Fractional shares will be rounded up to the nearest whole share.
