On June 29, 2023, Shareholders of National Instruments Corporation (NATI) voted concerning the proposed merger with Emersub CXIV, Inc., a wholly owned subsidiary of Emerson Electric Company. The merger was approved and subsequently consummated before the open on October 11, 2023. As a result, each existing NATI Common Share will be converted into the right to receive \$60.00 net cash per share.

Contract Adjustment

**New Deliverable
Per Contract:** \$6,000.00 Cash (\$60.00 x 100)

Settlement in NATI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of National Instruments Corporation options whose expiration dates are after 10-20-2023 will have their expiration dates advanced to 10-20-2023. Expiration dates occurring before 10-20-2023 (e.g., Flex options) will remain unchanged.

All National Instruments Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 10-20-2023

Existing American-style National Instruments Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
