On October 10, 2023, Xylophone Acquisition Corp., a wholly owned subsidiary of Harmony Biosciences Holdings, Inc. completed its tender offer for Zynerba Pharmaceuticals, Inc. The subsequent merger was consummated before the open on October 11, 2023. As a result, each existing ZYNE Common Share will be converted into the right to receive \$1.1059 cash plus one non-transferable contingent value right ("CVR").

Note: The CVR represents a non-transferable contractual right to receive additional payments. The adjusted ZYNE option deliverable will not include the non-transferable CVRs.

Contract Adjustment

**New Deliverable
Per Contract:** \$110.59 Cash (\$1.1059 x 100)

Settlement in ZYNE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Zynerba Pharmaceuticals, Inc. options whose expiration dates are after 10-20-2023 will have their expiration dates advanced to 10-20-2023. Expiration dates occurring before 10-20-2023 (e.g., Flex options) will remain unchanged.

All Zynerba Pharmaceuticals, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 10-20-2023

Existing American-style Zynerba Pharmaceuticals, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
