Subject: Adjusted Fortress Biotech, Inc. - Cash In Lieu Settlement

Adjusted Option Symbol: FBIO1

Adjusted Fortress Biotech, Inc. options were adjusted on October 10, 2023 (See OCC Information Memo #53333). The new deliverable became 1) 6 Fortress Biotech, Inc. (FBIO) Common Shares, and 2) Cash in lieu of approximately 0.6667 fractional FBIO Shares. Only settlement of the cash portion of FBIO1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.49 per whole FBIO share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

 $0.6667 \times 4.49 = 2.99 \text{ per FBIO1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of October 10, 2023 through October 31, 2023, to deliver the appropriate cash amount

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the FBIO1 options are as follows:

New Deliverable

Per Contract: 1) 6 Fortress Biotech, Inc. (FBIO) Common Shares

2) \$2.99 Cash

Strike Prices: Unchanged

CUSIP: FBIO: 34960Q307

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The FBIO component of FBIO1 exercise/assignment activity from October 10, 2023 through October 30, 2023, has settled through National Security Clearing Corporation (NSCC). The \$2.99 cash amount will be settled by OCC.

Pricing

The underlying price for FBIO1 will be determined as follows:

$$FBIO1 = 0.06 (FBIO) + 0.0299$$

For example, if FBIO closes at 1.70, the FBIO1 price would be calculated as follows:

$$FBIO1 = 0.06 (1.70) + 0.0299 = 0.13$$
