Subject: Mirati Therapeutics, Inc. – Anticipated Cash Settlement

On December 13, 2023, Shareholders of Mirati Therapeutics, Inc. (MRTX) will vote concerning the proposed merger with Vineyard Merger Sub Inc., a wholly owned subsidiary of Bristol-Myers Squibb Company. If the merger is approved and consummated, each existing MRTX Common Share will be converted into the right to receive \$58.00 Cash plus one non-transferable Contingent Value Right ("CVR") per share.

Note: The CVR represents a non-transferable contractual right to receive an additional payment. The adjusted MRTX option deliverable will not include the non-transferable CVRs.

<u>Exercise Considerations</u> – MRTX options will not call for the delivery of the CVRs. Call option holders who wish to receive the CVRs should exercise their options in sufficient time in advance of the contract adjustment. In all cases, it is the sole responsibility of persons holding call options seeking to receive the underlying securities to determine when to exercise their options.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.

Contract adjustment is expected to occur in the first half of 2024.

New Deliverable

Per Contract: \$5,800.00 Cash (\$58.00 x 100)

Settlement in MRTX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
