***** Update - Determination of Deliverable *****

Adjusted Western Asset Mortgage Capital Corporation options (adjusted option symbol WMC1) were adjusted on July 11, 2022 (See OCC Information Memo #50703). The new deliverable became 10 Western Asset Mortgage Capital Corporation (WMC) Common Shares.

On November 7, 2023, WMC Shareholders voted concerning the proposed merger with AG Mortgage Investment Trust, Inc. (MITT). The merger was approved and subsequently consummated before the open on December 6, 2023. As a result, each existing WMC Common Share will be converted into the right to receive 1.5 MITT Common Shares, subject to adjustment as described in the WMC/MITT Proxy Statement/Prospectus dated September 29, 2023 ("Proxy"), plus a pro rata portion of up to \$7,000,000 in cash consideration, calculated as described in the Proxy. Cash will be paid in lieu of fractional shares.

The merger consideration has been confirmed to be 1.498 AG Mortgage Investment Trust, Inc. (MITT) Common Shares and \$0.92 in cash per WMC share held.

The merger became effective, the WMC1 options will be further adjusted as follows:

Contract Adjustment

Date: December 6, 2023

New Multiplier: 100 (e.g., for premium extensions a premium of 1.50 equals \$150; a strike of 10 yields \$1,000.00).

Contract Multiplier: 1

Strike Prices: No Change

Option Symbol: 12/06/2023 - WMC1 remains WMC1 (with adjusted deliverable described below)
12/07/2023 - WMC1 changes to MITT1

Deliverable Per Contract: 1) 14 AG Mortgage Investment Trust, Inc. (MITT) Common Shares

- 2) Cash in lieu of 0.98 fractional MITT shares
- 3) \$9.20 Cash (\$0.92 x 10)

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for MITT1 will be determined as follows:

$$\text{MITT1} = 0.1498 (\text{MITT}) + 0.092$$

Delayed Settlement

The MITT component of the MITT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the MITT1 deliverable until the cash in lieu of fractional MITT shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
