On December 11, 2023, Morpheus Subsidiary Inc., a wholly owned subsidiary of United Therapeutics Corporation, completed its tender offer for Miromatrix Medical Inc. The subsequent merger was consummated before the open on December 13, 2023. As a result, each existing MIRO Common Share will be converted into the right to receive \$3.25 cash plus one non-transferable contingent value right ("CVR").

Note: The CVR represents a non-transferable contractual right to receive additional payments. The adjusted MIRO option deliverable will not include the non-transferable CVRs.

Contract Adjustment

Date: December 13, 2023

New Deliverable
Per Contract: \$325.00 Cash (\$3.25 x 100)

Settlement in MIRO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Miromatrix Medical Inc. options whose expiration dates are after 01-19-2024 will have their expiration dates advanced to 01-19-2024. Expiration dates occurring before 01-19-2024 (e.g., Flex options) will remain unchanged.

All Miromatrix Medical Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 01-19-2024

Existing American-style Miromatrix Medical Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
