On December 13, 2023, Shareholders of Navios Maritime Holdings Inc. (NM) voted concerning the proposed merger with Navigation Merger Sub Inc., a wholly owned subsidiary of N Logistics Holdings Corporation. The merger was approved and subsequently consummated before the open on December 14, 2023. As a result, each existing NM Common Share will be converted into the right to receive \$2.28 net cash per share.

Settlement in NM options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Navios Maritime Holdings Inc. options whose expiration dates are after 01-19-2024 will have their expiration dates advanced to 01-19-2024. Expiration dates occurring before 01-19-2024 (e.g., Flex options) will remain unchanged.

All Navios Maritime Holdings Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Navios Maritime Holdings Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
