Adjusted Esports Entertainment Group Inc. (adjusted option symbol GMBL1) options were adjusted on February 22, 2023 (See OCC Information Memo #51978). The new deliverable became 1 Esports Entertainment Group Inc. (GMBL) Common Share.

Esports Entertainment Group Inc. (GMBL) has announced a 1-for-400 reverse stock split. As a result of the reverse stock split, each GMBL Common Share will be converted into the right to receive 0.0025 (New) Esports Entertainment Group Inc. Common Shares. The reverse stock split will become effective before the market open on December 22, 2023. Fractional shares will be rounded up to the nearest whole share.

Adjusted GMBL1 options will be further adjusted to reflect the reverse split as described below:
