On December 4, 2023, Shareholders of Chindata Group Holdings Limited (CD) voted concerning the proposed merger with BCPE Chivalry Merger Sub Limited, a wholly owned subsidiary of BCPE Chivalry Bidco Limited. The merger was approved and subsequently consummated on December 18, 2023. **As a result, each existing CD American Depositary Share will be converted into the right to receive \$8.55 net cash per ADS (\$8.60 less \$0.05 cancellation fee).**

CD options, which were subject to delayed settlement from December 19, 2023 through December 21, 2023, are no longer subject to delayed settlement, effective December 22, 2023.

Settlement in CD options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Chindata Group Holdings Limited options whose expiration dates are after 01-19-2024 will have their expiration dates advanced to 01-19-2024. Expiration dates occurring before 01-19-2024 (e.g., Flex options) will remain unchanged.

All Chindata Group Holdings Limited options will utilize a \$.01 exercise threshold.

Existing American-style Chindata Group Holdings Limited options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
