Peraso Inc. (PRSO) has announced a 1-for-40 reverse stock split. As a result of the reverse stock split, each PRSO Common Share will be converted into the right to receive 0.025 (New) Peraso Inc. Common Shares. The reverse stock split will become effective before the market open on January 3, 2024. Fractional shares will be rounded up to the nearest whole share.
