Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is anticipated to occur in early April 2024.

New Multiplier: 100 (e.g., a premium of 1.50 yields \$150; a strike of 65 yields \$6,500.00)

New Deliverable Per Contract:

- 1) 495 Eastern Bankshares, Inc. (EBC) Common Shares
- 2) Cash in lieu of 0.6 fractional EBC Common Shares

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for EBC1 will be determined as follows:

$$\text{EBC1} = 4.956 (\text{EBC})$$

Delayed Settlement

The EBC component of the EBC1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the EBC1 deliverable until the cash in lieu of

fractional EBC shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On February 28, 2024, Shareholders of Cambridge Bancorp (CATC) will vote concerning the proposed merger with Eastern Bankshares, Inc. (EBC). If the merger is approved and consummated, each existing CATC Common Share will be converted into the right to receive 4.956 EBC Common Shares. Cash will be paid in lieu of fractional EBC shares.
