Subject: Livent Corporation - Cash In Lieu Settlement

Adjusted Option Symbol: ALTM1

Livent Corporation options were adjusted on January 4, 2024 (See OCC Information Memo #53893). The new deliverable became 1) 240 Arcadium Lithium plc (ALTM) Ordinary Shares, and 2) Cash in lieu of 0.6 fractional ALTM shares. Only settlement of the cash portion of ALTM1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.05 per whole ALTM share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

 $0.6 \times \$6.05 = \$3.63 \text{ per ALTM1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of January 4, 2024 through January 22, 2024, to deliver the appropriate cash amount

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the ALTM1 options are as follows:

New Deliverable

Per Contract: 1) 240 Arcadium Lithium plc (ALTM) Ordinary Shares

2) \$3.63 Cash

Strike Prices: Unchanged

CUSIP: ALTM: G0508H110

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The ALTM component of ALTM1 exercise/assignment activity from January 4, 2024 through January 19, 2024, has settled through National Security Clearing Corporation (NSCC). The \$3.63 cash amount will be settled by OCC.

Pricing

The underlying price for ALTM1 will be determined as follows:

$$ALTM1 = 2.40 (ALTM) + 0.0363$$

For example, if ALTM closes at 5.07, the ALTM1 price would be calculated as follows:

$$ALTM1 = 2.40 (5.07) + 0.0363 = 12.20$$
