On December 13, 2023, Shareholders of Mirati Therapeutics, Inc. (MRTX) voted concerning the proposed merger with Vineyard Merger Sub Inc., a wholly owned subsidiary of Bristol-Myers Squibb Company. The merger was approved and subsequently consummated before the open on January 23, 2024. As a result, each existing MRTX Common Share will be converted into the right to receive \$58.00 Cash plus one non-transferable Contingent Value Right ("CVR") per share.

Note: The CVR represents a non-transferable contractual right to receive an additional payment. The adjusted MRTX option deliverable will not include the non-transferable CVRs.

Contract Adjustment

**New Deliverable
Per Contract:** \$5,800.00 Cash (\$58.00 x 100)

Settlement in MRTX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Mirati Therapeutics, Inc. options whose expiration dates are after 02-16-2024 will have their expiration dates advanced to 02-16-2024. Expiration dates occurring before 02-16-2024 (e.g., Flex options) will remain unchanged.

All Mirati Therapeutics, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Mirati Therapeutics, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
