Subject: Adjusted Eargo, Inc. – Anticipated Further Adjustment/Anticipated Cash Settlement

Adjusted Eargo, Inc. (adjusted option symbol EAR1) options were adjusted on January 18, 2023 (See OCC Information Memo #51777). The new deliverable became 5 Eargo, Inc. (EAR) Common Shares.

On February 13, 2024, Shareholders of Eargo, Inc. (EAR) will vote concerning the proposed merger with PSC Echo Merger Sub Inc., a wholly owned subsidiary of PSC Echo Parent LLC, both are affiliates of PSC Echo, LP. If the merger is approved and consummated, each existing EAR Common Share will be converted into the right to receive \$2.55 net cash per share.

If and when the merger is approved and consummated, adjusted EAR1 options will be further adjusted as described below.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the first quarter of 2024.

**New Deliverable
Per Contract:** \$12.75 Cash (\$2.55 x 5)

Settlement in EAR1 options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
