**Subject:** Spirit Realty Capital, Inc. - Cash In Lieu Settlement  
Adjusted Option Symbol: O1

Spirit Realty Capital, Inc. options were adjusted on January 23, 2024 (See OCC Information Memo #53992). The new deliverable became 1) 76 Realty Income Corporation (O) Common Shares, and 2) Cash in lieu of 0.2 fractional O Common Shares. Only settlement of the cash portion of O1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$55.16 per whole O share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.2 \times \$55.16 = \$11.03 \text{ per O1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of January 23, 2024 through January 30, 2024, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the O1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 76 Realty Income Corporation (O) Common Shares  
2) \$11.03 Cash

**Strike Prices:** Unchanged

**CUSIP:** O: 756109104

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The O component of O1 exercise/assignment activity from January 23, 2024 through January 29, 2024, has settled through National Security Clearing Corporation (NSCC). The \$11.03 cash amount will be settled by OCC.

## **Pricing**

The underlying price for O1 will be determined as follows:

$$O1 = 0.76 (O) + 0.1103$$

For example, if O closes at 54.92, the O1 price would be calculated as follows:

$$O1 = 0.76 (54.92) + 0.1103 = 41.85$$
