Subject: Adjusted Inovio Pharmaceuticals, Inc. - Cash In Lieu Settlement

Adjusted Option Symbol: INO1

Adjusted Inovio Pharmaceuticals, Inc. options were adjusted on January 25, 2024 (See OCC Information Memo #53995). The new deliverable became 1) 8 Inovio Pharmaceuticals, Inc. (INO) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional INO Shares. Only settlement of the cash portion of INO1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.93 per whole INO share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

 $0.3333 \times \$6.93 = \$2.31 \text{ per INO1 Contract}$ 

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of January 25, 2024 through February 05, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the INO1 options are as follows:

**New Deliverable** 

**Per Contract:** 1) 8 Inovio Pharmaceuticals, Inc. Common Shares

2) \$2.31 Cash

Strike Prices: Unchanged

**CUSIP:** INO: 45773H409

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

## Settlement

The INO component of INO1 exercise/assignment activity from January 25, 2024 through February 2, 2024, has settled through National Security Clearing Corporation (NSCC). The \$2.31 cash amount will be settled by OCC.

## **Pricing**

The underlying price for INO1 will be determined as follows:

$$INO1 = 0.08 (INO) + 0.0231$$

For example, if INO closes at 5.04, the INO1 price would be calculated as follows:

$$INO1 = 0.08 (5.04) + 0.0231 = 0.43$$
