The PFIS component of the PFIS1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the PFIS1 deliverable until the cash in lieu of fractional PFIS shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On March 22, 2024, Shareholders of FNCB Bancorp, Inc. (FNCB) will vote concerning the proposed merger with Peoples Financial Services Corporation (PFIS). If the merger is approved and consummated, each existing FNCB Common Share will be converted into the right to receive 0.146 PFIS Common Shares. Cash will be paid in lieu of fractional PFIS shares.
