Assembly Biosciences, Inc. (ASMB) has announced a 1-for-12 reverse stock split. As a result of the reverse stock split, each ASMB Common Share will be converted into the right to receive approximately 0.083333 (New) Assembly Biosciences, Inc. Common Shares. The reverse stock split will become effective before the market open on February 12, 2024. Cash will be paid in lieu of fractional shares.

The ASMB component of the ASMB1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ASMB1 deliverable until the cash in lieu of fractional ASMB Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
