Subject: IRSA Inversiones y Representaciones S.A. – Cash In Lieu Settlement

Adjusted Option Symbol: IRS1

Adjusted IRSA Inversiones y Representaciones S.A. options were adjusted on October 3, 2023 and December 6, 2023 (See OCC Information Memos #53396 and #54045). The new deliverable became 1) 91 IRSA Inversiones y Representaciones S.A. (IRS) Global Depositary Shares, 2) \$4.46 Cash, and 3) Cash in lieu of 0.57306419 fractional IRS shares, if any.

OCC has been informed that a price of \$8.65006 per whole IRS share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

0.57306419 x \$8.65006 = \$4.96 per IRS1 Contract

Additionally, a \$0.05 DR Issuance fee per issued Global Depositary Share is applicable. Thus, the total cash per lieu amount included in the IRS1 deliverable is:

\$4.96 - (1 share distributed x \$0.05) = \$4.96 - \$0.05 = \$4.91 per IRS1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of December 6, 2023 through February 13, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the IRS1 options are as follows:

New Deliverable

Per Contract: 1) 91 IRSA Inversiones v Representaciones S.A. (IRS) Global

Depositary Shares

2) \$9.37 Cash (\$4.46 + \$4.91)

Strike Prices: Unchanged

CUSIP: IRS: 450047303

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The IRS component of IRS1 exercise/assignment activity from December 6, 2023 through February 12, 2024, has settled through National Security Clearing Corporation (NSCC). The \$9.37 cash amount will be settled by OCC.

Pricing

The underlying price for IRS1 will be determined as follows:

$$IRS1 = 0.91 (IRS) + 0.0937$$

For example, if IRS closes at 7.93, the IRS1 price would be calculated as follows:

$$IRS1 = 0.91 (7.93) + 0.0937 = 7.31$$
