Adjusted Vaccinex, Inc. Options were adjusted on September 26, 2023 (See OCC Information Memo #53256). The new deliverable became 7 Vaccinex, Inc. (VCNX) Common Shares.

Vaccinex, Inc. (VCNX) has announced a 1-for-14 reverse stock split. As a result of the reverse stock split, each VCNX Common Share will be converted into the right to receive approximately 0.071428571 (New) Vaccinex, Inc. Common Shares. The reverse stock split will become effective before the market open on February 20, 2024. Fractional shares will be rounded up to the nearest whole share.
