Subject: Adjusted Alaunos Therapeutics, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: TCRT1

Adjusted Alaunos Therapeutics, Inc. options were adjusted on February 1, 2024 (See OCC Information Memo #54029). The new deliverable became 1) 6 Alaunos Therapeutics, Inc. (TCRT) Common Shares and 2) Cash in lieu of approximately 0.6667 fractional TCRT Shares. Only settlement of the cash portion of TCRT1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$2.529 per whole TCRT share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$2.529 = \$1.69 \text{ per TCRT1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of February 1, 2024 through February 16, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the TCRT1 options are as follows:

New Deliverable

Per Contract: 1) 6 Alaunos Therapeutics, Inc. (TCRT) Common Shares
2) \$1.69 Cash

Strike Prices: Unchanged

CUSIP: TCRT: 98973P200

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The TCRT component of TCRT1 exercise/assignment activity from February 1, 2024 through February 15, 2024, has settled through National Security Clearing Corporation (NSCC). The \$1.69 cash amount will be settled by OCC.

Pricing

The underlying price for TCRT1 will be determined as follows:

$$\text{TCRT1} = 0.06 (\text{TCRT}) + 0.0169$$

For example, if TCRT closes at 1.59, the TCRT1 price would be calculated as follows:

$$\text{TCRT1} = 0.06 (1.59) + 0.0169 = 0.11$$
