## Subject: Cresud S.A.C.I.F. y A. – Cash In Lieu Settlement Adjusted Option Symbol: CRES1

Adjusted Cresud S.A.C.I.F. y A. options (adjusted option symbol CRES1) were adjusted on May 10, 2023 and again on December 6, 2023 (See OCC Information Memo #52757 and #54086). The new deliverable became 1) 103 Cresud S.A.C.I.F. y A. (CRESY) American Depositary Shares, 2) Cash in lieu of 0.00519878 fractional CRESY shares, if any, 3) 3 IRSA Inversiones y Representaciones S.A. (IRS) Global Depositary Shares, 4) Cash in lieu of 0.83424732 fractional IRS Shares, if any, and 5) \$1.23 Cash. Only settlement of the cash portion of CRES1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$9.25 per whole CRESY share will be used to determine the cash in lieu amount for the CRESY stock dividend. Additionally, a \$0.05 DR Issuance fee per issued CRESY share is applicable. Accordingly, the cash in lieu amount of fractional CRESY shares, less fees, is:

0.00519878 x \$9.25 - (1 share distributed x \$0.05) = \$0.05 - \$0.05 = \$0.00 per CRES1 Contract

OCC has been informed that a price of \$9.00 per whole IRS share will be used to determine the cash in lieu amount for the distribution of IRS shares. Additionally, a \$0.05 DR Issuance fee per issued IRS share is applicable. Accordingly, the cash in lieu amount of fractional IRS shares, less fees, is:

0.83424732 x \$9.00 - (3 shares distributed x \$0.05) = \$7.51 - \$0.15 = \$7.36 per CRES1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of December 6, 2023 through February 21, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the CRES1 options are as follows:

New Deliverable Per Contract:

1) 103 Cresud S.A.C.I.F. y A. (CRESY) American Depositary Shares 2) 3 IRSA Inversiones y Representaciones S.A. (IRS) Global Depositary Shares 3) \$8.59 Cash (\$7.36 + \$1.23)

Multiplier:	100 (i.e., a premium of 1.50 yields \$150)

## <u>Settlement</u>

The CRESY and IRS components of CRES1 exercise/assignment activity from December 6, 2023 through February 20, 2024, have settled through National Security Clearing Corporation (NSCC). The \$8.59 cash amount will be settled by OCC.

## **Pricing**

The underlying price for CRES1 will be determined as follows:

CRES1 = 1.03 (CRESY) + 0.03 (IRS) + 0.0859

For example, if CRESY closes at 8.40 and IRS closes at 8.63, the CRES1 price would be calculated as follows:

CRES1 = 1.03 (8.40) + 0.03 (8.63) + 0.0859 = 9.00
