Subject: Adjusted Precision BioSciences, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: DTIL1

Adjusted Precision BioSciences, Inc. options were adjusted on February 14, 2024 (See OCC Information Memo #54109). The new deliverable became 1) 3 Precision BioSciences, Inc. (DTIL) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional DTIL Shares. Only settlement of the cash portion of DTIL1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$11.81 per whole DTIL share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$11.81 = \$3.94 \text{ per DTIL1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of February 14, 2024 through February 22, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the DTIL1 options are as follows:

New Deliverable

Per Contract: 1) 3 Precision BioSciences, Inc. (DTIL) Common Shares
2) \$3.94 Cash

Strike Prices: Unchanged

CUSIP: DTIL: 74019P207

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The DTIL component of DTIL1 exercise/assignment activity from February 14, 2024 through February 21, 2024, has settled through National Security Clearing Corporation (NSCC). The \$3.94 cash amount will be settled by OCC.

Pricing

The underlying price for DTIL1 will be determined as follows:

$$\text{DTIL1} = 0.03 (\text{DTIL}) + 0.0394$$

For example, if DTIL closes at 12.36, the DTIL1 price would be calculated as follows:

$$\text{DTIL1} = 0.03 (12.36) + 0.0394 = 0.41$$
