Faraday Future Intelligent Electric Inc. (FFIE) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each FFIE Common Share will be converted into the right to receive approximately 0.333333 (New) Faraday Future Intelligent Electric Inc. Common Shares. The reverse stock split will become effective before the market open on March 1, 2024. Fractional shares will be rounded up to the nearest whole share.
