On February 20, 2024, Shareholders of Gracell Biotechnologies Inc. (GRCL) voted concerning the proposed merger with Grey Wolf Merger Sub, a wholly owned subsidiary of AstraZeneca Treasury Limited. The merger was approved and subsequently consummated before the open on February 22, 2024. **As a result, each existing GRCL American Depositary Share will be converted into the right to receive \$9.95 net cash per ADS (\$10.00 less \$0.05 cancellation fee).**

Note: The CVRs represent a non-transferable contractual right to receive a contingent payment. The adjusted GRCL option deliverable will not include the non-transferable CVRs.

Contract Adjustment

New Deliverable
Per Contract: \$995.00 Cash (\$9.95 x 100)

GRCL options, which were subject to delayed settlement from February 22, 2024 through February 28, 2024, are no longer subject to delayed settlement, effective February 29, 2024.

Settlement in GRCL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Gracell Biotechnologies Inc. options whose expiration dates are after 03-15-2024 will have their expiration dates advanced to 03-15-2024. Expiration dates occurring before 03-15-2024 (e.g., Flex options) will remain unchanged.

All Gracell Biotechnologies Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Gracell Biotechnologies Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
