On February 7, 2024, Investment Managers Series Trust II announced it will liquidate the AXS Cannabis ETF (THCX). THCX shares were suspended from trading on the New York Stock Exchange before the open on February 22, 2024. Proceeds of the liquidation were distributed to shareholders in the amount of \$16.71871 per THCX share on March 1, 2024.

Contract Adjustment

The option symbol THCX will not change.

New Deliverable

Per Contract: \$1,671.87 Cash (\$16.71871 x 100)

THCX options, which were subject to delayed settlement from February 22, 2024 through February 29, 2024, are no longer subject to delayed settlement, effective March 1, 2024.

Settlement in THCX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of AXS Cannabis ETF options whose expiration dates are after 03-15-2024 will have their expiration dates advanced to 03-15-2024. Expiration dates occurring before 03-15-2024 (e.g., Flex options) will remain unchanged.

All AXS Cannabis ETF options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 03-15-2024

Existing American-style AXS Cannabis ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
