 Arrow Reverse Cap 500 ETF - Liquidation/Cash Settlement/Acceleration of Expirations Option Symbol: YPS Date: 03/01/2024

On February 12, 2024, Arrow Investment Advisors announced it will liquidate the Arrow Reverse Cap 500 ETF (YPS). YPS shares were suspended from trading on BATS Global Markets before the open on February 27, 2024. Proceeds of the liquidation were distributed to shareholders in the amount of \$22.3493 per YPS share on March 1, 2024.

Contract Adjustment

The option symbol YPS will not change.

YPS options, which were subject to delayed settlement from February 27, 2024 through February 29, 2024, are no longer subject to delayed settlement, effective March 1, 2024.

Settlement in YPS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Arrow Reverse Cap 500 ETF options whose expiration dates are after 03-15-2024 will have their expiration dates advanced to 03-15-2024. Expiration dates occurring before 03-15-2024 (e.g., Flex options) will remain unchanged.

All Arrow Reverse Cap 500 ETF options will utilize a \$.01 exercise threshold.

Option Symbol: YPS Existing Expiration: All months New expiration date: 03-15-2024

Existing American-style Arrow Reverse Cap 500 ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
