On February 21, 2024, Collaborative Investment Series Trust announced it will liquidate the Rareview InflationDeflation ETF (FLTN). The last day of trading of FLTN shares on BATS Global Markets was February 29, 2024. **Proceeds of the liquidation were distributed to shareholders in the amount of \$19.11699455 per FLTN share on March 1, 2024.**

Contract Adjustment

The option symbol FLTN will not change.

New Deliverable
Per Contract: \$1,911.70 Cash (\$19.11699455 x 100)

FLTN options, which were delayed on March 1, 2024, are no longer subject to delayed settlement, effective March 4, 2024.

Settlement in FLTN options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Rareview InflationDeflation ETF options whose expiration dates are after 03-15-2024 will have their expiration dates advanced to 03-15-2024. Expiration dates occurring before 03-15-2024 (e.g., Flex options) will remain unchanged.

All Rareview InflationDeflation ETF options will utilize a \$.01 exercise threshold.

New expiration date: 03-15-2024

Existing American-style Rareview InflationDeflation ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
