On April 5, 2024, Shareholders of Eagle Bulk Shipping Inc. (EGLE) will vote concerning the proposed merger with Star Bulk Carriers Corporation (SBLK). If the merger is approved and consummated, each existing EGLE Common Share will be converted into the right to receive 2.6211 SBLK Common Shares. Cash will be paid in lieu of fractional SBLK shares.
