Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for TCPC1 will be determined as follows:

$$\text{TCPC1} = 0.3834 (\text{TCPC})$$

**Delayed Settlement**

The TCPC component of the TCPC1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the TCPC1 deliverable until the cash in lieu of fractional TCPC shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

## **Background**

On March 7, 2024, Shareholders of BlackRock Capital Investment Corporation (BKCC) approved the proposed merger with BlackRock TCP Capital Corporation (TCPC). The merger was consummated on March 18, 2024. As a result, each existing BKCC Common Share will be converted into the right to receive 0.3834 TCPC Common Shares. Cash will be paid in lieu of fractional TCPC shares.
