Cartesian Therapeutics, Inc. (RNAC) has announced a 1-for-30 reverse stock split. As a result of the reverse stock split, each RNAC Common Share will be converted into the right to receive approximately 0.033333 (New) Cartesian Therapeutics, Inc. Common Shares. The reverse stock split will become effective before the market open on April 5, 2024. Cash will be paid in lieu of fractional shares.

The RNAC component of the RNAC2 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the RNAC2 deliverable until the cash in lieu of fractional RNAC Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
