Marin Software Incorporated (MRIN) has announced a 1-for-6 reverse stock split. As a result of the reverse stock split, each MRIN Common Share will be converted into the right to receive approximately 0.166667 (New) Marin Software Incorporated Common Shares. The reverse stock split will become effective before the market open on April 15, 2024. Cash will be paid in lieu of fractional shares.

Delayed Settlement

The MRIN component of the MRIN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the MRIN1 deliverable until the cash in lieu of fractional MRIN Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
