Subject: Adjusted MINISO Group Holding Limited - Cash Distribution Settlement
Adjusted Option Symbol: MNSO1

Adjusted MINISO Group Holding Limited options were adjusted on March 27, 2024 (See OCC Information Memo #54294). The new deliverable became 1) 100 MINISO Group Holding Limited (MNSO) American Depositary Shares and 2) Approximately \$28.00 Cash (approximately \$0.28 x 100). Only settlement of the cash component of MNSO1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that the final distribution rate is \$0.28 (\$0.29 gross dividend rate less \$0.01 dividend fee) per MNSO share held.

Now that the distribution ratio has been determined, OCC will require Put exercisers and Call assignees, during the period of March 27, 2024 through April 12, 2024, to deliver the appropriate cash amount.

Terms of the MNSO1 options are as follows:

New Deliverable

Per Contract: 1) 100 MINISO Group Holding Limited (MNSO) American Depositary Shares
2) \$28.00 Cash (\$0.28 x 100)

Strike Prices: Unchanged

CUSIP: 66981J102

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The MNSO component of MNSO1 exercise/assignment activity has settled through National Security Clearing Corporation (NSCC). The \$28.00 cash amount will be settled by OCC.

Pricing

The underlying price for MNSO1 options will be determined as follows:

$$\text{MNSO1} = \text{MNSO} + 0.28$$

For example, if MNSO closes at 21.51, the MNSO1 price would be calculated as follows:

$$\text{MNSO1} = 21.51 + 0.28 = 21.79$$
