Subject: Adjusted Cartesian Therapeutics, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: RNAC2

Adjusted Cartesian Therapeutics, Inc. (adjusted symbol RNAC2) options were adjusted on April 5, 2024 (See OCC Information Memo #54424). The new deliverable became 1) 3 Cartesian Therapeutics, Inc. (RNAC) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional RNAC Shares. Only settlement of the cash portion of RNAC2 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$20.328 per whole RNAC share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

0.3333 x \$20.328 = \$6.78 per RNAC2 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 5, 2024 through April 23, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the RNAC2 options are as follows:

New Deliverable

Per Contract: 1) 3 Cartesian Therapeutics, Inc. (RNAC) Common Shares

2) \$6.78 Cash

Strike Prices: Unchanged

CUSIP: RNAC: 816212302

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

<u>Settlement</u>

The RNAC component of RNAC2 exercise/assignment activity from April 5, 2024 through April 22, 2024, has settled through National Security Clearing Corporation (NSCC). The \$6.78 cash amount will be settled by OCC.

Pricing

The underlying price for RNAC2 will be determined as follows:

$$RNAC2 = 0.03 (RNAC) + 0.0678$$

For example, if RNAC closes at 18.26, the RNAC2 price would be calculated as follows:

$$RNAC2 = 0.03 (18.26) + 0.0678 = 0.62$$
