Bakkt Holdings, Inc. (BKKT) has announced a 1-for-25 reverse stock split. As a result of the reverse stock split, each BKKT Class A Common Share will be converted into the right to receive 0.04 (New) Bakkt Holdings, Inc. Class A Common Shares. The reverse stock split will become effective before the market open on April 29, 2024.
