BioCardia, Inc. (BCDA) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each BCDA Common Share will be converted into the right to receive approximately 0.066667 (New) BioCardia, Inc. Common Shares. The reverse stock split will become effective before the market open on May 30, 2024. Cash will be paid in lieu of fractional shares.

Pricing

Until the cash in lieu amount is determined, the underlying price for BCDA1 will be determined as follows:

$$\text{BCDA1} = 0.066667 (\text{BCDA})$$

Delayed Settlement

The BCDA component of the BCDA1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the BCDA1 deliverable until the cash in lieu of fractional BCDA Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
