On June 18, 2024, Shareholders of Nuvei Corporation (NVEI) will vote concerning the proposed Plan of Arrangement with Neon Maple Purchaser Inc., a wholly owned subsidiary of Advent International, L.P. If the merger is approved and consummated, each existing NVEI Subordinate Voting Share will be converted into the right to receive \$34.00 net cash per share.

## **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.

Contract adjustment is expected to occur in late 2024 or the first guarter of

2025.

New Deliverable

**Per Contract:** \$3,400.00 Cash (\$34.00 x 100)

Settlement in NVEI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
