Adjusted Lufax Holding Ltd (adjusted option symbol LU1) options were adjusted on December 15, 2023 (See OCC Information Memo #53608). The new deliverable became 25 (New) Lufax Holding Ltd (LU) American Depositary Shares.

Lufax Holding Ltd (LU) has announced a Special Dividend of approximately \$2.42, less fees, if any, per LU American Depositary Share. ADS holders can elect to receive the Special Dividend in the form of new ADSs through Citibank N.A., the Depository. **LU ADS holders who do not make a valid election will receive the Special Dividend in the form of cash.** The record date is June 4, 2024; payable date is August 6, 2024. The ex-distribution date for this distribution will be June 4, 2024.

The election deadline is unknown at this time.

Exercise Consideration - On June 4, 2024, LU1 options will be further adjusted to include a cash component in the amount to be received by ADS holders who fail to make a valid election. LU Call option holders who do not wish to receive the distribution in the form distributed to non-electing ADS holders must exercise their options in sufficient time in advance of the contract adjustment and observe all conditions of the election. In all cases, it is the sole responsibility of persons holding call options seeking to participate in the election to determine when to exercise their options and to comply with all terms and conditions of the election.

LU1 options will be further adjusted to reflect the Election Dividend as described below.

Options Contract Adjustment

Effective Date: June 4, 2024

New Multiplier: 100 (e.g., for premium extensions a premium of 1.50 equals \$150; a strike of 5 yields \$500.00).

Contract Multiplier: 1

Strike Prices: No Change

Option Symbol: LU1 remains LU1

- 1) 25 Lufax Holding Ltd (LU) American Depositary Shares
- 2) Approximately \$60.50 Cash (approximately \$2.42 x 25), less fees, if any

Pricing

Until the final net cash dividend amount is determined, the underlying price for LU1 will be determined as follows:

$$\text{LU1} = 0.25 (\text{LU}) + 0.605$$

Delayed Settlement

The LU component of the LU1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the LU1 deliverable until exact cash amount is determined. Upon determination of the exact cash amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
