Delayed Settlement

The ILMN and GRAL components of the ILMN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ILMN1 deliverable until the cash in lieu of fractional GRAL Common Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

illumina, Inc. (ILMN) has announced a distribution of (New) GRAIL, Inc. (GRAL) Common Shares. The distribution ratio is approximately 0.166667 of a GRAL share for each ILMN share held. The record date is June 13, 2024; the payable date is June 24, 2024. The NASDAQ has set June 25, 2024, as the ex-distribution date for this distribution. Cash will be paid in lieu of fractional GRAL shares.

GRAIL, Inc. Common Shares will begin trading on a when issued basis on June 12, 2024 on the NASDAQ under the trading symbol "GRALV".
