**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is anticipated to occur in late 2024.

**Option Symbol:** HMST changes to FSUN1

**Strike Divisor:** 1

**Contracts Multiplier:** 1

**New Multiplier:** 100 (e.g., a premium of 1.50 yields \$150; a strike of 8 yields \$800.00)

**New Deliverable Per Contract:**

- 1) 38 FirstSun Capital Bancorp (FSUN) Common Shares
- 2) Cash in lieu of 0.67 fractional FSUN shares

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for FSUN1 will be determined as follows:

$$\text{FSUN1} = 0.3867 (\text{FSUN})$$

**Delayed Settlement**

The FSUN component of the FSUN1 deliverable will settle through National Securities Clearing Corporation

(NSCC). OCC will delay settlement of the cash portion of the FSUN1 deliverable until the cash in lieu of fractional FSUN share is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

### **Background**

On June 18, 2024, Shareholders of HomeStreet, Inc. (HMST) will vote concerning the proposed merger with FirstSun Capital Bancorp (FSUN). If the merger is approved and consummated, each existing HMST Common Share will be converted into the right to receive 0.3867 FSUN Common Shares. Cash will be paid in lieu of fractional FSUN shares.
