Subject: Adjusted BioCardia, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: BCDA1

Adjusted BioCardia, Inc. options were adjusted on May 30, 2024 (See OCC Information Memo #54639). The new deliverable became 1) 6 BioCardia, Inc. Common Shares and 2) Cash in lieu of approximately 0.6667 fractional BCDA Shares. Only settlement of the cash portion of BCDA1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$5.1735 per whole BCDA share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$5.1735 = \$3.45 \text{ per BCDA1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of May 30, 2024 through June 12, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the BCDA1 options are as follows:

New Deliverable

Per Contract: 1) 6 BioCardia, Inc. Common Shares
2) \$3.45 Cash

Strike Prices: Unchanged

CUSIP: BCDA: 09060U606

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The BCDA component of BCDA1 exercise/assignment activity from May 30, 2024 through June 11, 2024, has settled through National Security Clearing Corporation (NSCC). The \$3.45 cash amount will be settled by OCC.

Pricing

The underlying price for BCDA1 will be determined as follows:

$$\text{BCDA1} = 0.06 (\text{BCDA}) + 0.0345$$

For example, if BCDA closes at 3.64, the BCDA1 price would be calculated as follows:

$$\text{BCDA1} = 0.06 (3.64) + 0.0345 = 0.25$$
