Subject: Adjusted Petróleo Brasileiro S.A. - Petrobras - Cash Distribution Settlement
Adjusted Option Symbol: PBRA1

Adjusted Petróleo Brasileiro S.A. - Petrobras options were adjusted on May 3, 2024 (See OCC Information Memo #54529). The new deliverable became 1) 100 Petróleo Brasileiro S.A. - Petrobras (PBRA) American Depositary Shares and 2) Approximately \$68.11 Cash (approximately $\$0.6811062 \times 100$). Only settlement of the cash component of PBRA1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that the final cash distribution amount is \$0.669222 per PBRA share held.

Now that the cash distribution amount has been determined, OCC will require Put exercisers and Call assignees, during the period of May 3, 2024 through June 28, 2024, to deliver the appropriate cash amount.

Terms of the PBRA1 options are as follows:

New Deliverable Per Contract: 1) 100 Petróleo Brasileiro S.A. - Petrobras (PBRA) American Depositary Shares
2) \$66.92 Cash ($\0.669222×100)

Strike Prices: Unchanged

CUSIPS: 71654V101

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The PBRA component of PBRA1 exercise/assignment activity delayed from May 3, 2024 through June 27, 2024 has settled through National Security Clearing Corporation (NSCC). The \$66.92 cash amount will be settled by OCC.

Pricing

The underlying price for PBRA1 options will be determined as follows:

$$\text{PBRA1} = \text{PBRA} + 0.6692$$

For example, if PBRA closes at 13.68, the PBRA1 price would be calculated as follows:

$$\text{PBRA1} = 13.68 + 0.6692 = 14.35$$
