ASLAN Pharmaceuticals Limited (ASLN) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each ASLN American Depositary Share will be converted into the right to receive 0.125 (New) ASLAN Pharmaceuticals Limited American Depositary Shares. The reverse stock split will become effective before the market open on July 3, 2024. Cash will be paid in lieu of fractional shares. There will be an ADS cancellation fee of \$0.025 per ASLN ADS held at the effective time of the reverse split.

Note: If the cash in lieu entitlement, if any, per ASLN1 contract is less than the applicable fees, then no cash in lieu amount will be associated with the ASLN1 option deliverable. Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

## **Pricing**

Until the cash in lieu amount is determined, the underlying price for ASLN1 will be determined as follows:

$$\text{ASLN1} = 0.125 (\text{ASLN})$$

## **Delayed Settlement**

The ASLN component of the ASLN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ASLN1 deliverable until the cash in lieu of fractional ASLN Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
