Subject: Adjusted Vicarious Surgical Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: RBOT1

Adjusted Vicarious Surgical Inc. options were adjusted on June 13, 2024 (See OCC Information Memo #54703). The new deliverable became 1) 3 Vicarious Surgical Inc. (RBOT) Class A Common Shares and 2) Cash in lieu of approximately 0.3333 fractional RBOT Shares. Only settlement of the cash portion of RBOT1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.940489 per whole RBOT share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$6.940489 = \$2.31 \text{ per RBOT1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 13, 2024 through July 02, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the RBOT1 options are as follows:

New Deliverable

Per Contract: 1) 3 Vicarious Surgical Inc. (RBOT) Class A Common Shares
2) \$2.31 Cash

Strike Prices: Unchanged

CUSIP: RBOT: 92561V208

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The RBOT component of RBOT1 exercise/assignment activity from June 13, 2024 through July 1, 2024, has settled through National Security Clearing Corporation (NSCC). The \$2.31 cash amount will be settled by OCC.

Pricing

The underlying price for RBOT1 will be determined as follows:

$$\text{RBOT1} = 0.03 (\text{RBOT}) + 0.0231$$

For example, if RBOT closes at 5.40, the RBOT1 price would be calculated as follows:

$$\text{RBOT1} = 0.03 (5.40) + 0.0231 = 0.19$$
