## **Delayed Settlement**

The AFCG and SUNS components of the AFCG1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the AFCG1 deliverable until the cash in lieu of fractional SUNS Common Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

## **Background**

AFC Gamma, Inc. (AFCG) has announced a distribution of (New) Sunrise Realty Trust, Inc. (SUNS) Common Shares. The distribution ratio is approximately 0.333333 of a SUNS share for each AFCG share held. The record date is July 8, 2024; the payable date is July 9, 2024. The NASDAQ has set July 10, 2024, as the ex-distribution date for this distribution.

Sunrise Realty Trust, Inc. Common Shares began trading on a when issued basis on July 9, 2024 on the NASDAQ under the trading symbol "SUNSV".
